

Resolution to Oppose the Approval of Michigan SB 574, Which Would Divert Funding from County Enhancement Millages from Traditional Public Schools to Charter Schools; Urge House Representatives to vote "No" on the Companion House Bill; Recommend that the Michigan legislature establish measures of public accountability for Charter Schools.

Minutes of a regular meeting of the Board of Education of the Ann Arbor Public Schools held at Allen Elementary School, 2560 Towner, Ann Arbor, MI 48104, held on the 25th day of October, 2017 at 7:00 p.m., prevailing Eastern Time.

The meeting was called to order by member <u>Stead</u>.

The following preamble and resolution were offered by Member <u>Gaynor</u> and supported by Member Baskett.

WHEREAS the Ann Arbor Public Schools Board of Education believes that maintaining strong and financially secure public schools is the best route to providing equal opportunity to all; and

WHEREAS the Ann Arbor Public Schools Board of Education believes that public schools, being funded by public money, must be held accountable to the public; and

WHEREAS charter schools have significantly less operating costs (lower salaries, no or less pension obligations, no or less transportation costs, etc.) and virtual schools have fewer facility and staffing costs relative to traditional public schools; and

WHEREAS about 83 percent of Michigan charter schools are private for-profit businesses with little or no financial transparency, and are operated by boards of directors that are appointed by those chartering the schools, not elected, and are therefore not accountable to the public; and

WHEREAS the Michigan Senate, on October 18, 2017, passed SB 574, which would require money raised from county enhancement millages to be shared with charter and virtual schools that are headquartered within the millage region; and

WHEREAS SB 574 would grant public money to private charter companies that are unaccountable to the public; and

WHEREAS the language of SB 574 is ambiguous and could be interpreted to refer to current millages, thereby changing the allocation of their revenue a posteriori; and

WHEREAS state funding in Michigan has already put traditional public schools at significant financial and operating risk by diverting those funds to private for-profit charter schools; and

WHEREAS SB 574 would divert a larger share of millage funding from traditional public schools in districts with the greatest needs, i.e., urban districts, which have the highest concentration of charter schools and lowest tax payment capacity;

NOW, THEREFORE, IT IS HEREBY RESOLVED:

The Ann Arbor Public Schools Board of Education:

- Opposes SB 574 and any similar bill that transfers money away from traditional public schools that are held accountable to the public for their policies;
- Urges all Michigan Representatives in the House to vote "no" on the companion bill to SB 574;
- Urges the House and Senate to require the same stringent public accountability measures, for charter schools as it does for traditional public schools, including financial and academic standards;
- Urges Michigan Governor Rick Snyder to veto any bill that diverts money from enhanced millages from traditional public schools;
- Urges that the legislature consider the Michigan Education Finance Study, the upcoming study commissioned by the School Finance Research Collaborative, and matters of equity when deliberating over education funding;
- Directs the Executive Assistant of the Ann Arbor Public Schools Board of Education to transmit copies of this resolution to:
